“Any other charitable object that can be carried out by a Registered Society as a social landlord with the Regulator for Social Housing.

The Association’s Mission is:

Application for membership is open to

- any tenant of the Association
- any individual over the age 18 living or working within the Associations operating area.
- corporate and unincorporate bodies active within the Associations operating area.

When considering applications for membership the Board will have regard to:

- the rules of the Association
- potential conflicts of interest
- whether applicants are paid staff or board members of other housing providers

and will consider each application on its merits.

The membership fee is £1. As a Community Benefit Society that it also the limit of members financial liability for the Association.

To become a member, application should be made in writing to the Association’s registered office, and should be accompanied by the £1 required to purchase a share.

Application will be considered by the Board at the next available meeting. If the application is approved the applicant will be issued with a share. If the application is not approved the applicant will be advised and his or her money returned.
